**Morningside coaches and wrestlers will be running small groups and showing techniques, with three sessions focused on take downs, top and bottom positions.**

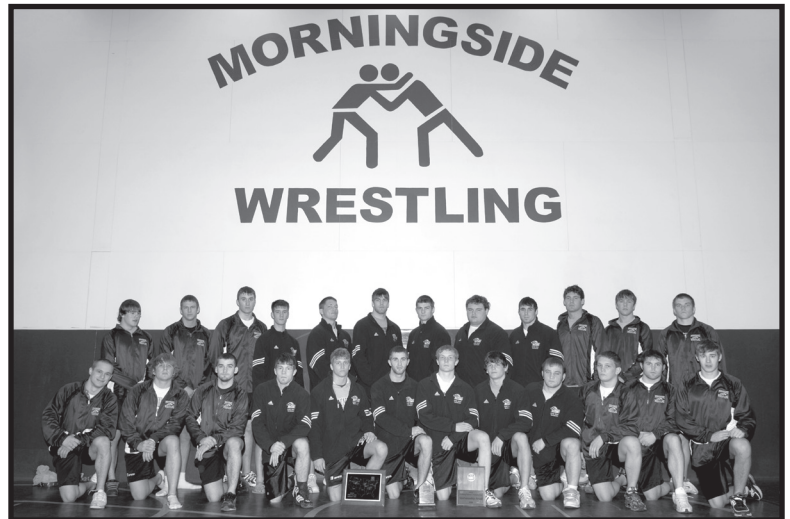
